Tax claimed by the charity

- The charity will **reclaim 25p** of tax on every £1 you give on or after 1 April 2018 (unless instructed otherwise) .

You can donate in following ways:

If your Donation is by way of internet banking /(BACS) transfer

- Collect Bank account number and sort code details from treasurer
- Enter **your name** or **Gift Aid Ref** as reference for identification on church bank statement

If your Donation is by way of Standing order

- Collect standing order form from treasurer
- Complete form and **return to** treasurer for forwarding to the bank

If your Donation is by way of Text

- Text **360LIFE** followed by amount you wish to donate to **70460**, e.g. “360LIFE 3”, if you wish to donate £3.

At the end of each Tax year you will be advised of the amount of Gift Aid tax that will be claimed on your offering in the previous tax year . If you have paid less tax than the amount of gift aid tax, please get in touch with the treasurer asap to make an adjustment in the claim.

If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.
